

#### **USE OF VENUE**

#### **EXCLUSIVITY**

To book the venue exclusively, the minimum spend is \$5000, which includes food and drink.

#### LOGISTICS

No event will exceed 5 hours. All guests must depart by 11pm, and all payment must be completed prior to 11pm. Please arrange suitable transport for guests to and from the venue. We are not responsible for calling taxis and we absolutely prohibit guests to park on council property, including nature strips and lawns. It's the obligation of the guest to leave the venue in a respectful and quiet manner, and our obligation to make your transition from venue to transport home as seamlessly and quietly as possible. We will ask your guests to leave in a respectful manner if we need to.



#### **DECOR**

We allow 2 hours prior to the event for bump in and 1 hour for bump out. This includes any and all decorative items. Personal property must be collected by end of business the following day or the items will be disposed of, including cakes. We accept absolutely no responsibility for decorative items or personal property and will not compensate for any lost, stolen, or broken items, including wedding gifts or monetary envelopes. We will take all reasonable care to respect your belongings, but we are unable to store items for more than 24 hours or take responsibility for them throughout the duration of the event.

#### DAMAGE AND RESPONSIBILTY

The client will be financially accountable for any loss or damage which is caused to the venue by any guests of your function. You will supervise all children in attendance, and the management has the right to ask you to rectify this throughout the function if it is found that there are children not being supervised. If a child is injured, particularly whilst not being supervised by an adult, we cannot and will not take responsibility.

#### ALCOHOL AND GUEST BEHAVIOUR

Stellina is committed to the responsible service of alcohol at all times. Stelling is located in a residential area and has committed to respecting our neighbours. Stellina reserves the right to refuse entry, refuse service or remove any person that management feels is in any way behaving contrary to what is deemed acceptable by the approved government bodies or our venue management plan. Under no circumstances will any persons who are intoxicated by alcohol or any other substance be allowed entry or permitted to stay on the premises. If a person is asked to leave, no compensation will be afforded to any member of the function or its host if a member of the function is refused entry, refused service or removed from the premises. If a guest is asked to leave the premises and refuses to do so, management is required by law to notify the police immediately and that person may be subject to fine for 'failure to depart a licensed premises'. Any persons involved in criminal activity such as violence, sale or use of prohibited drugs or possession of weaponry will be turned over to the police immediately without hesitation. Any guest that harrasses staff or demands service of alcohol after being cut off or placed on a break will be immediately exited from the venue without any hesitation or negotiation. Do not attempt to loophole this policy by purchasing alcohol for a guest that has been placed on a break or cut off. Anybody found doing this will also be exited from the venue, without exception. Dress Regulations do apply. Minimum requirements are smart casual wear.

#### MUSIC

Volume is strictly managed due to being located in a residential area. Music volume is at the manager's discretion. DJ's are not permitted. If a meal is required by your musician, you must make this known and include them in your guest count for catering.

#### **CAKE**

Hosts are welcome to bring their own cake. A modest fee of \$1.50 per person attending is charged. We will store it and take every care however we can accept no responsibility to any damage that may occur. We will provide you with a cake knife and napkins free of charge, and professionally cut and serve the cake for you.
